Ever since the threshold increase to \$1,000 (one thousand) for the crime of Grand Larceny, communities across our commonwealth and our nation have seen an increase in crimes such as shoplifting and general larceny. Make no mistake, this is not a coincidence. The message that has been sent to the criminal is that private property is not valued, and the crime of stealing will not be taken serious by our courts. This attitude has succeeded in emboldening the thief and has served to place the property owner, manager, and employees of stores, in harms way. It is NOT the victimless crime some would believe. Often, these stolen items end up for sale via a secondary market which places the unsuspecting buyer in danger or could cause them to be liable for purchasing stolen goods.

Your effort to decrease the threshold, and to increase sentencing of repeat offenders, will have a positive effect in reducing crime and decreasing the victimization of innocent property owners and businesses.
